## 7. Report: Superintendent (10 min)

In Apryl's absence Keely offered the Superintendent report.

Steve asked if this would be the meeting where a decision would be made about our membership. Keely anticipated a positive decision.

## 8. Report: Principal (7 min)

School council AGM will be on October 8th and meetings will flow every other month from there

Action: Mary will check the regulation for the timing of the school council AGM.

# 9. Report: Secretary-Treasurer (7 min)

Keely indicated that, in theory, the end of July is the deadline on the capital plan and the SCAAP, but that deadline may be flexible.

There were seven charter school applications this year and one was declined.

This week families will be receiving transport cheques so that is a nice way to end the school year.

The office has established a number of electronic payment process, replacing paper processes which has made the work more manageable.

We are still waiting to hear about new parcels of funding from Alberta Education, for example, the mental health budget and the capital budget. There will be some work to be done in August to iron these out.

The Alberta Teachers' Association has announced a strike action, although our teachers are not in, if it leads to a wage bump then this will be passed on to teachers. A further consequence is that we may receive an extra bump in demand for places.

Administration will explore options around any other enrollment drive throughout the summer.

The KG, nursery and gym spaces will all form part of the application by WESE for an after school care license.

Keely shared the enrollment report with the Board.

#### 10. Q3 (Q1-Q3 combined) review.

The Board reviewed the reports and commended the administration for excellent progress since this time last year.

11. Date for upcoming board events.

The WISE Charter School Annual General Meeting requires 21 days' notice; and must be on or before November 30th.
